

How can I file a dispute on Venmo? ({{Timely Interaction Matters}})

To file a Venmo +1-708-462- 2770 dispute: Go to Me tab > select transaction > +1-708-462-2770

After completing the information fields, review your submission carefully to ensure that everything is accurate. When you're ready, select the option to **submit the issue**. Your dispute request will then be sent to Venmo's support system for review.

Time Limits for Filing a Dispute

It's important to be aware of the time frame for reporting problems. Venmo generally allows users to submit disputes within certain time limits depending on the type of transaction.

For transactions related to **purchases**, users typically have up to **180 days** from the date of the payment to report an issue. This longer window allows time for buyers

to recognize problems such as items not arriving or purchases that don't match what was promised. +1-708-462- 2770

For other types of payment errors, such as accidental transfers or certain transaction mistakes, +1-708-462- 2770
